NOTICE TO SHAREHOLDERS

RE: Inclusion of ETFs into Invesco's Securities Lending Programme and changes to Securities Lending Levels

(each fund listed in Schedule 1 is a "Fund" and together the "Funds").

Dear Shareholder

We are writing to you as a Shareholder of the Fund/s, each a sub-fund of Invesco Markets II plc (the "Company"), to inform you of changes relating to the Fund's involvement in Invesco's securities lending programme (the "Programme"). Funds/share classes and their corresponding ISINs can be found in Schedule 1 attached to this notice.

Changes

Following a review of the collateral rules for the Programme, the Directors have determined that the following changes will be made:

- Funds which have ESG characteristics will be included in the Programme, as set out in Schedule 1. Invesco
 believes the inclusion of the Funds in the Programme will not compromise the ESG characteristics of the
 Funds and will be beneficial to investors. The Fund's offering documents will be updated accordingly.
 - For the fixed income Funds which have ESG characteristics as set out in Schedule 1, the securities lending levels have been updated to show that between 0% and 30% of the Fund's assets may be subject to securities lending;
 - b) For the equity Funds which have ESG characteristics as set out in Schedule 1, the securities lending levels have been updated to show that between 0% and 15% of the Fund's assets may be subject to securities lending; and
- 2) For the government bond Funds, as set out in Schedule 1, the securities lending levels will be updated to show an increase in the Fund's assets which may be subject to securities lending from between 0% and 30%, to between 0% and 50%. The Directors have determined that this increase in securities lending is appropriate, proportionate, and does not impact on the Investment Manager's ability to manage and monitor the risks arising from the increase in securities lending. This measure aims to increase consistency and price competitiveness of Invesco's product range.

Effective Date

The Changes are subject to regulatory approval, and Invesco expects them to be effective from on or around 13 March 2023. The Funds' offering documents will be amended in due course to reflect these Changes, and will be available to Shareholders free of charge.

Should you wish to redeem your shareholding as a result of the Changes, you may do so in accordance with the dealing provisions outlined in the Prospectus.

General

All capitalised terms used in this notice shall bear the same meaning as the capitalised and defined terms used in the Prospectus.
