Dear Shareholder,

We are writing to you as a Shareholder of the Funds, each a sub-fund of Invesco Markets plc (the "Company"), to inform you of the following methodology changes.

Background and purpose

On 11 June 2025, following a market consultation, the index provider announced changes to the index methodologies of the Reference Indices tracked by the Funds.

According to the revised methodology of the Funds:

 Component selection: In relation to the criteria that at least ten stocks must remain in the relevant sector. The methodology will be updated such that in the event that a sector contains less than 10 stocks at review date, then the rule shall be relaxed so that all stocks of that sector remain in the relevant sector

2. **Weighting cap factors**: The weighting capping will be amended such that a cap of 18% is applied if the Reference Index has less than 25 components (reduced from 20%). If there are less than 6 components in the Reference Index the components will be equal weighted.

The changes are expected to facilitate the Funds' continued compliance with UCITS diversification limits.

The changes will not result in any material change to the Fund's exposures and there will be no change to the investment objective or policies as a result.

Effective date

The changes will take place on the effective date of 22 September 2025.

Should you wish to redeem your shareholding as a result of the Change, you may do so in accordance with the dealing provisions outlined in the Supplement.
