Dear Shareholder,

We are writing to you as a shareholder of the Sub-Fund to inform you about upcoming changes to Man Umbrella SICAV (the "**SICAV**") and the Sub-Funds.

Unless otherwise indicated below, the changes to the prospectus of the SICAV (the "**Prospectus**") will take effect as from 2 June 2025 (the "**Effective Date**").

1. Change of the Sub-Fund's name

As of 30 June 2025, the Sub-Fund shall be re-named into "<u>Man Trend Alternative</u>" due to the following reasons:

- As the Man Group, as initiator of the SICAV, is conducting a re-organisation of its sub-brands to support the firm's updated strategy and vision to align with its growth strategy across all client channels, it will focus on three core investment propositions: "*Discretionary, Systematic and Solutions*". This will provide greater clarity on the firm's investment platform and mean the firm is easier for allocators to understand and navigate.
- While the "Man AHL"-strategies will generally fall under the Systematic label and the use of the systematic sub-brands e.g. "Man AHL" for certain platforms shall be still maintained, for products which are primarily retail-focussed, the Man Group considers that the "Man"-brand will support asset-raising rather than various sub-funds providing greater clarity to investors on the investment platforms of the Man Group.

Such change shall be reflected to the general part of the Prospectus, the Supplement 2 of the Prospectus, as well as Annex 2 of the Prospectus.

For the avoidance of doubt, this name change of the Sub-Fund will not result in any change to the investment policy / strategy of the Sub-Fund or lead to any rebalancing of the Sub-Fund's portfolio.

2. Revised Prospectus and further information

The revised Prospectus will also reflect and include non-material changes that have no significant impact on the shareholders of the Sub-Fund, in particular:

- i. Amendment of the section "Distribution Policy" of the general part of the Prospectus with respect to the timing of the payment of the dividends of Income Share classes;
- ii. Amendment of several sections of the general part of the Prospectus with respect to the disclosures in relation to anti-money laundering and counter the financing of terrorism ("AML/CFT") measures in view of latest legal and regulatory developments in this regard.

The revised Prospectus will be available free of charge at the registered office of the SICAV.

The changes described above will be reflected within the Prospectus dating 2 June 2025.
